3. Stormwater maintenance and wetland restoration by removing and chemically treating exotic species.

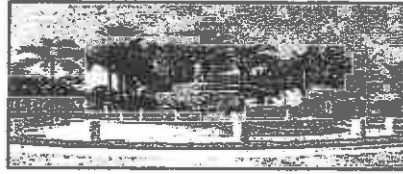
